HOW can I meet 12+ debit card transactions totaling \$100 each month during COVID-19?

Here are some ways and ideas to meet the monthly transaction requirements and still **EARN** on your **Performance Checking** account.

✓ **Update reoccurring monthly payments if you're not doing so already.**

- Utility Bills

✓ **Same-Day Delivery on a wide range of services.**

- Order groceries: *Whole Foods Prime, Postmates, Instacart, Walmart*
- Order meals: *UberEats, DoorDash, Grubhub*
- Target Same Day Delivery through Shipt – *great for household essentials, personal care, school/office supply and even groceries!*

✓ **Pay with your Mobile Wallet** – your debit card will be encrypted making it a safe alternative. You can check-out using your mobile wallet on most online retailers.

- Examples of a few mobile wallet providers: *Apple Pay, Google Wallet, Samsung Pay*
